Rules & Regulations

1. Eligibility (Inter-Collegiate Participation)

- AURA is an **Inter-College Fashion Confluence** open to students from **recognized colleges and universities**.
- All participants must be **bonafide students** of their respective institutions.
- Participants are required to carry a **valid College Identity Card** and produce it for verification upon request.

2. Team Composition

- Each team shall comprise **4 members (2 pairs)**.
- **One pair will perform under each prescribed theme**.
- Teams with incomplete or incorrect composition shall not be permitted to perform.

3. Themes

- **Traditional / Retro Glamour** – 1 pair
- **Western** – 1 pair
- Participants must strictly adhere to the **allotted themes**.
- Any deviation from the theme may lead to **penalization or disqualification**.

4. Limited Entries (First-Come, First-Served Basis)

- **Only 20 teams** shall be permitted to participate.
- Registration will be accepted strictly on a **first-come, first-served basis**.
- Once the maximum number of teams is reached, **registrations for will be closed without prior notice**.



5. Time Limit

- Each team will be allotted **3 minutes on the ramp**.
- Exceeding the stipulated time limit may result in **deduction of marks or disqualification**, as decided by the judges.

6. Costumes & Props

- Costumes must be **decent, appropriate, and strictly theme-based, reflecting the ethos of the event**.
- In keeping with the **values of Indian culture, decorum, and dignity, outfits should maintain modesty; therefore, dresses or garments above knee length are not permitted**.
- **Handheld props are permitted**, subject to approval by the organizing committee.
- **Sharp objects, hazardous materials, fire, liquids, or any unsafe props are strictly prohibited**.

7. Judging Criteria

Evaluation shall be based on the following parameters:

- Costume & Styling
- Creativity & Theme Interpretation
- Confidence & Stage Presence
- Ramp Walk
- Overall Presentation
- The **decision of the judging panel shall be final and binding**, and no appeals shall be entertained.

8. Reporting, Conduct & Discipline

- All participants must **report on time** as per the schedule communicated by the organizers.
- Participants must maintain **strict discipline and professional conduct** both on stage and backstage.
- Any form of indiscipline, misbehaviour, or violation of rules may lead to **immediate disqualification**.

9. General Instructions

- Use of **obscene gestures, or indecent portrayal** is strictly prohibited.



- The organizing committee reserves the **right to amend, modify, or interpret the rules** as deemed necessary.
- The institution shall not be responsible for **loss or damage of personal belongings**.
- Participation implies **acceptance of all rules and regulations** of the event.
